Rationale

The National Curriculum 2014 states that:

Every state-funded school must offer a curriculum which is balanced and broadly based and which:

- *promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and*
- *prepares pupils at the school for the opportunities, responsibilities and experiences of later life.*

2.5 All schools should make provision for personal, social, health and economic education (PSHE), drawing on good practice.

Although there is no set programme of study for PHSEE it is essential in supporting children's whole development and an integral part of the pastoral curriculum and care.

Aims

The overarching aim for PSHEE education is to provide pupils with:

- accurate and relevant knowledge
- opportunities to turn that knowledge into personal understanding
- opportunities to explore, clarify and if necessary challenge, their own and others' values, attitudes, beliefs, rights and responsibilities
- the skills and strategies they need in order to live healthy, safe, fulfilling, responsible and balanced lives.

Overarching Concepts of PHSEE:

- Identity (their personal qualities, attitudes, skills, attributes and achievements and what influences these)
- Relationships (including different types and in different settings)
- A healthy (including physically, emotionally and socially) balanced lifestyle (including within relationships, work-life, exercise and rest, spending and saving and diet)
- Risk (to be managed rather than simply avoided) and safety (including behaviour and strategies in different settings)
- Diversity and equality (in all its forms)
- Rights, responsibilities (including fairness and justice) and consent (in different contexts)
- Change (as something to be managed) and resilience (the skills, strategies and 'inner resources' we can draw on when faced with challenging change or circumstance)
- Power (how it is used and encountered in a variety of contexts including persuasion, bullying, negotiation and 'win-win' outcomes)
- Career (including enterprise and economic understanding).

Organisation of PHSEE at Field Lane Primary

Each class has a timetabled slot for PHSEE which may be taught in a variety of ways including circle time, class debates or drama and role play. These will be the main approaches used for the delivery of specific PHSEE issues. There are also opportunities for learning, which is linked, to the other curriculum areas such as science, art, R.E, history and geography. These will be used for the teaching and consolidation of related objectives. Aspects of PSHEE are taught as part of carousel sessions this applies to KS2 children and may be as a complete SEAL unit or as more discrete topic e.g. debating or Philosophy for Children. Whole school events throughout the year including the Young Entrepreneurs Christmas Fair, British Values and Friendship week also include aspects of PSHEE.

PHSEE lessons should be active, with children playing a full role in all lessons. For this reason there is little emphasis on the production of written, assessable work. Outside agencies will be involved where and when appropriate.

Main Content Areas:

The following themes, as suggested by the PHSEE Association, form our curriculum provision:

- Health & Well-Being
- Relationships
- Living in the wider world – Economic well-being and being a responsible citizen
- Teachers are proactive in linking areas of IPC theme with PHSCE where relevant.

Assessment: There is no formal assessment of PHSEE and Citizenship according to national guidelines. Children’s development in this area will be measured via records for behaviour and attendance, bullying, parental and pupil views, learning observations and external views of the school. Pupils personal achievements in this area may be recognised and celebrated by being awarded certificates in weekly Praise assembly and through our termly and yearly citizen and helpful hands awards.

Confidentiality: Rules should be agreed with the class concerning appropriate behaviour and language use during PHSEE lessons. These could follow the circle time model, which is already used by most members of staff.

Where a child makes a disclosure of a particularly sensitive nature, it must be made explicit to the child that they were right to say what they did, but it cannot remain a “secret” between the teacher and the child. School safeguarding procedures will be followed if this happens.

Dissemination and Review

This policy, once approved by the Governing Body, will be reviewed annually.

This policy should be read in conjunction with the P.S.H.E.E, R.E British Values and Safeguarding policies.
